

Mathematics Illinois Assessment of Readiness "Spring" 2021


Percent of Students Meeting or Exceeding Expectations (Level 4/Level 5)



Due to the Covid-19 pandemic, schools had the option to take the Spring 2021 IAR assessment in the Spring of 2021 or Fall of 2021. The IAR Assessment, or Illinois Assessment of Readiness, is a mandatory Illinois assessment given to students in grades 3 through 8. Cass Junior High 8th grade students completed the assessment in the Spring of 2021. Students in grades 3rd-7th grade during the 2020-2021 school year completed their grade level assessment in Fall 2021. This means 4th grade students in the Fall of 2021 completed the 3rd grade IAR assessment, 5th grade in the Fall of 2021 completed the 4th grade assessment, 6th grade in the Fall of 2021 completed the 5th grade assessment, 7th grade students in the Fall of 2021 completed the 6th grade assessment, and 8th grade students in the Fall of 2021 completed the 7th grade assessment.


Reading Illinois Assessment of Readiness "Spring" 2021


NWEA Comparison to Prepandemic Norms 2022 Mathematics
