Minutes of the Meeting of the Board of Education of Cass School District 63, DuPage County, Illinois; held at Indian Prairie Public Library at 7:00 P.M. on the 9th Day of July, 2024.

Update Regarding Joint Food Service Management Request for Proposals

Mr. Cross reviewed a summary of the proposals from three potential food service management companies for the 2024-25 lunch program. This concluded a long process working with our partner Center Cass School District 66, while complying with the rules and regulations through the National School Lunch Program and the Illinois State Board of Education.

B. Review of Recommended Food Service Management Company Vended Fixed Price Meal Contract

Mr. Cross shared that after completing required taste testings, reviewing proposals, and checking references on all three potential vendors, the six-member committee of the two school districts was unanimous in the recommendation to move forward with Just A Dash Catering as the food service vendor for the 2024-25 school year.

Mr. Cross shared with the Board that he believes Just A Dash will provide high quality and fresh lunches for our students, with more transparency related to ingredients and nutritional value. This will end the current partnership with Aramark, who has been the lunch program provider for District 63 for many years.

III. Recommended Action Items

A. Approval of Recommended Food Service Management

Vice President Patel moved and Member Green seconded a motion to approve a food service management company vended fixed price meal contract with Just A Dash Catering for the 2024-25 school year.

B. Approval of 2024-25 Food Service Agreement with Center Cass School District 66

Mr. Cross stated that this intergovernmental agreement is an annual agreement with District 66 to continue our partnership to run the lunch program.

Member Marinelli moved and Member Mitha seconded a motion to approve the 2024-25 Food Service Agreement with Center Cass School District 66.

C. Approval of 2024-25 Student Lunch Fees

Mr. Cross reviewed the results of the parent survey that was conducted in the spring which showed that parents overall were supportive of keeping the prices as low as possible, while also achieving the goal of improving quality. After holding some discussion on costs and how reimbursements work, the Board was in agreement to establish the 2024-25 lunch prices at \$4.00, and later review pricing for the 2025-26 year to see if adjustments are necessary.

Member Wyent moved and Member Green seconded a motion to approve the student lunch fee cost at \$4.00 for the 2024-25 school year.
